## MEMBERSHIP DUES

Membership dues shall be remitted monthly to the Institute no later than the 25<sup>th</sup> of the month following the month in which product was delivered or work performed in the State of Colorado or Wyoming. Dues are \$50 per month or payment according to the following schedule, whichever is greater. If a member qualifies for multiple categories, the higher dues category will be assigned.

The RMMI Contractor Dues for Level 2 includes up to \$900 of education each year. Levels 3 through 10 include up to \$1,800 in education each year. Education can include enrollment in the Masonry Apprenticeship Program, which is \$900 per semester. RMMI now offers the RMMI Certification Classes monthly. Cost for members is \$150 per class. The education benefit must be used within the membership calendar year and does not carry forward.
